 Board member Bailey initiated a discussion regarding Special Districts and lack of federal funds for COVID-19. Board member Sharma advised that his district was inquiring into a process to try and obtain funds. Executive Director Schimke stated he would research and forward information to the entire Board.

#### 8. Excess Coverage Costs for 2021/2022

Executive Director Schimke reviewed the preliminary rates for 2021/2022 Excess Workers' Compensation coverage through PRISM. He advised the Board that the NCSDIA was in PRISM's low safety group. He noted that rates were down 2% from the 2020-2021 year. He shared with the Board that the NCSDIA's SIR was 300K per occurrence.

No action was taken by the Board.

## 9. NCSDIA Actuarial Study for 2021/2022

Executive Director Schimke introduced Mike Harrington, President of Bickmore Actuarial. Mike Harrington updated the board on the status of NCSDIA's studies as of the June 30, 2021. He advised them that the total outstanding liabilities increased by \$868,000 over last year. He also noted that estimates for the 21/22 total working up \$155,00 over 20/21. Lastly, he pointed out that the pool was funded at the 80% confidence level. Executive Director Schimke advised the board that this program was in the excellent financial condition.

#### 10. Workers' Compensation Contributions 2021/2022

Executive Director Schimke and Mike Harrington of Bickmore Actuarial presented the preliminary workers' compensation contributions for 21/22. Over total pool rates were up 7% over 20/21. Board member Sharma inquired as to the Cosumnes CSD's rate. He requested that that the CSD's loss history be forwarded to him.
